A new article through OSBF's strategic grant has been released. In "Dark Waters" in Ohio: Our rich natural resources are under threat form industry and farms, they highlight the increasing dangers of industrial and agricultural sources on Ohio's precious water resources.

Ohio environmental activists hope the new film *Dark Waters*, which tells the true story of

Cincinnati corporate defense lawyer Rob Bilott who sued chemical giant DuPont on behalf of West Virginia residents, will help draw attention to our own water resources that are at risk. Thanks to threats from sediment, manure, fertilizers, and a growing variety of chemical pollutants, nearly half of Ohio's waterways do not meet the standards required under the Clean Water Act for fishing, swimming, and drinking.





The 2019 Fellows Class has been busy at work planning the first-ever Fellows Week of Service, which will highlight the intersection of human trafficking and foster care.

The week will now begin on Sunday, April 26 and end on Saturday, May 2. This is an exciting change - allowing the Fellows more time to plan and the ability to highlight Law Day on May 1 of the week.

The Fellows Week of Service will kick off with an evening event at the Ohio Statehouse on April 27. We will be hearing inspiring stories and ways to get involved to combat this important issue.

The Fellows will also be collecting suitcases for a Stuff the Suitcase campaign. Stay tuned for more details on how you can get involved!

Thanks to a grant from the OSBF, the **Dominican Sisters of Peace's Martin de Porres Center** has been able to educate the Ohio Latino community on legal issues and offer legal assistance. They have held five legal education sessions, hosted two



citizenship workshops, and assisted five people in becoming U.S. citizens.

This past fall, the Dominican Sisters of Peace were awarded another grant for the Martin de Porres Center's Legal Education for Latino Families Program. Through this, they will continue providing legal education for Latino families on citizenship, immigration laws, employment, and how-tos on completing legal forms through workshops and educational sessions.
