### **Courtroom Victories**

#### **ARGUMENT IN THE CASE *NAVISTAR, INC. VS. DUTCHMAID LOGISTICS, INC.***

Mark's argument at the Ohio Supreme Court on April 13, 2022. KLH and the Weisbrod firm out of Texas represented Dutchmaid Logistics, Inc. and obtained a 7 figure jury verdict in Newark, Ohio including attorney fees, fraud, and punitive damages. #### **A CROSS-EXAMINATION IN THE CASE, *C&R, INC. VS. LIBERTY MUTUAL INSURANCE CO.***

Read Kitrick's cross-examination of the main defendant-agent. Attorney Doug Roberts requested Kitrick as co-counsel to try the bad faith claim against his client's insurance agent and the agent's employer, Liberty Mutual. Upon cross-examination, he was able to get the agent to admit to making a false statement. The case settled as Kitrick began his closing argument. At stake was a \$1 million UM/UDM policy.
